PARENTAL CONSENT AND RELEASE OF LIABILITY
REGARDING COVID-19 AND OTHER MATTERS

I, _____, the undersigned parent or legal guardian of the above-named minor (the "*Minor*"), have registered the Minor as a student or participant in Centerville Academy's dance school or other school or program located at 1248 North Main Street, Centerville, Utah 84014 (the "*School*"), owned and operated by or on behalf of Jedediah Flintlock LLC, Centerville Academy LLC and SalliJune Anderson, an individual (collectively, the "*Academy*"), and may do so again in the future. In connection therewith, by signing below, I hereby consent to the Minor being a student at the School and participating in all the programs and activities offered or arranged by or on behalf of the Academy on or about or outside of the School (collectively, the "*Activities*"). I understand that the purpose of the Minor participating in the Activities is to aid in the enhancement of the Minor's education and well-being. In consideration of the Academy permitting the Minor to be a student at the School and otherwise participate in the Activities, I acknowledge and agree (to the maximum extent permitted by law) as follows:

1. I acknowledge and agree that the Activities involve various inherent risks and may be hazardous to the Minor. I recognize that the Minor's participation in the Activities will significantly increase various risks, including without limitation (a) risks to the Minor's health such as (i) potential exposure to COVID-19 and other disease or illness, (ii) allergy-related complications, and/or (iii) physical strain or injury, and (b) other risks such as (i) injury to the Minor caused by the Minor's own actions or omissions, (ii) injury to the Minor caused by the actions or omissions of others, and/or (iii) injury to other parties. I recognize that these risks are impossible to eliminate fully even by implementation of all feasible safety measures and the most prudent and careful conduct on the part of the Academy.
2. **I AM FULLY AWARE OF THE NATURE, PURPOSE AND RISKS OF ATTENDING THE SCHOOL AND OTHERWISE PARTICIPATING IN THE ACTIVITIES. I ACKNOWLEDGE THAT THE ACTIVITIES CAN BE AND/OR ARE POTENTIALLY AND INHERENTLY DANGEROUS AND KNOWINGLY AND FREELY ASSUME ALL RISKS ASSOCIATED WITH ANY ACTIVITIES THAT THE MINOR MAY PARTICIPATE IN WHILE ATTENDING THE SCHOOL, INCLUDING WITHOUT LIMITATION ALL RISKS OF COVID-19 EXPOSURE OR OTHER ILLNESS, INJURY, DISABILITY, DEATH AND/OR DAMAGE OR LOSS OF PROPERTY, AND ALL THOSE RISKS SPECIFICALLY SET FORTH HEREIN, BOTH KNOWN AND UNKNOWN, AND ASSUME FULL RESPONSIBILITY FOR THE MINOR'S PARTICIPATION IN ALL ACTIVITIES.**
3. **I ACKNOWLEDGE AND AGREE THAT THE ACADEMY IS NOT REQUIRING OR REQUESTING THAT THE MINOR COME TO THE SCHOOL OR OTHERWISE PARTICIPATE IN ANY ACTIVITIES. THE MINOR'S REGISTRATION AND ATTENDANCE AT THE SCHOOL AND PARTICIPATION IN ACTIVITIES IS COMPLETELY OPTIONAL AND VOLUNTARY. I ACKNOWLEDGE THAT MASKS ARE OPTIONAL AT THE SCHOOL AND IN CONNECTION WITH PARTICIPATING IN THE ACTIVITIES AND THAT THE ACADEMY WILL NOT BE CHECKING TEMPERATURES OR REQUIRING HEALTH QUESTIONNAIRES. I AGREE THAT I WILL NOT SEND THE MINOR TO THE SCHOOL IF HE OR SHE HAS, OR HAS RECENTLY HAD, ANY COVID-19 SYMPTOMS, OR IF HE OR SHE HAS RECENTLY BEEN EXPOSED TO SOMEONE WHO HAD A CONFIRMED CASE OF COVID-19, IN COMPLIANCE WITH ALL GOVERNMENT RECOMMENDATIONS, RULES AND LAWS.**
4. I, for myself and on behalf of the Minor and my executors, administrators, heirs, next of kin, representatives, successors and assigns, and family members (collectively, the "*Releasing Parties*"), agree to protect, defend, hold harmless, and indemnify, and do release, remise and forever discharge, the Academy and the Academy's successors, assigns, affiliates, landlord, present and former direct and indirect owners, employees, independent contractors, managers, trustees, consultants, board members, officers, directors, attorneys, agents and other representatives (collectively, the "*Released Parties*"), from and against any and all claims, actions, causes of action, proceedings, suits, costs, liabilities, damages, and expenses, whether known or unknown (including but not limited to all direct, special, incidental, exemplary, punitive, and consequential damages, losses of any kind and attorneys' fees), and however caused, including without limitation by intentional, reckless, negligent or grossly negligent conduct (collectively, "*Claims*"), that are based upon, result from, and/or relate in any way to the Minor's registration or attendance at the School, or the Minor's participation in any of the Activities, including without limitation with respect to (a) any exposure to COVID-19 or any other disease or illness; (b) the actions or omissions of any party accompanying the Minor; (c) transportation to and from the School or any such Activities; (d) instruction given or the condition or utilization of any facilities or equipment with respect to the School or Activities; (e) any failure by me or the Minor to completely and accurately provide any information requested by the Academy or any of the other Released Parties; (f) any misrepresentation or false statement made by me or the Minor to the Academy or any of the other Released Parties; and (g) my breach of any provision of any registration agreement or other agreement with the Academy or any of the other Released Parties. Additionally, and without limiting the foregoing, I, for myself and for all of the other Releasing Parties, waive any Claims any of us, whether individually or collectively, may now or in the future have against the Academy or any of the other Released Parties with respect to the matters released hereunder, and agree not to initiate or prosecute (or aid any other party in prosecuting) or continue any Claim of any kind whatsoever against any of the Released Parties in any court or otherwise with respect to the matters released hereunder, including but not limited to any Claim under any common law, whether in law or equity, or federal, state or local statute, ordinance or rule of law.
5. I acknowledge and agree that this Parental Consent and Release of Liability (this "*Release Agreement*") is intended to be as broad and inclusive as is permitted by law and that if any portion hereof is held invalid, the balance shall continue in full legal force and effect. I acknowledge that I am familiar with the legal principle that provides that a general release does not extend to claims which the releasor does not know or suspect to exist in the releasor's favor at the time of executing the release, which if known by the
